CONSTITUTIONAL PROVISIONS

ARTICLE I

ARTICLE II

SECTION 1. All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

SECTION 2. The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors in that State.

SECTION 3. The Senate shall be composed of two Senators from each State, chosen by the Legislature thereof, for a Term of six Years; and each Senator shall have the Qualifications requisite for Senators in that State.

SECTION 1. The executive Power shall be vested in a President of the United States of America.

SECTION 2. The President shall hold Office, for a Term of four Years; and shall be re-eligible to that Office.

SECTION 3. The President shall have Power, by and with the Advice and Consent of the Senate, to make Treaties, provided two thirds of the Senators present concur; and he shall nominate, and by and with the Advice and Consent of the Senate, shall appoint and dismiss Ambassadors, Ministers, Consuls, Judges, and all other Officers of the United States, whose Appointments are in his Power; except such as the Laws may provide shall be appointed by the Congress; and he shall receive such Oath of Office as the Congress may from time to time prescribe.

SECTION 1. The judicial Power shall extend to all Cases, in Law and Equity, arising under this Constitution, the Laws of the United States, and Treaties made, or which shall be made, under the Authority of the United States; to all Cases affecting Ambassadors, Consuls, and other public Ministers and Consuls; to all Cases of Admiralty and Maritime Jurisdiction; to all Cases of Controversy between two or more States; between a State and Citizens of another State; between Citizens of different States; between Citizens of the same State claiming Lands under Grants of different States, and between a State and foreign Citizens, Subjects or Companies.

SECTION 2. The judicial Power shall extend to all Cases of Impeachment.

SECTION 3. The President, Judges, and all Officers of the United States, shall be impeachable and liable to Impeachment by the House of Representatives; and the Senate shall have the sole Power to try all Impeachments; and no Person shall be tried during his Continuance in Office.
